

NOTICE

The applications are hereby invited on the prescribed "Format" from the desirous Ex-Servicemen and their widows of Himachal Pradesh. Only those Ex-Servicemen are eligible whose truck have not been attached earlier with ACC Ltd. Barmana, Ambuja Cement Limited, Darlaghat and Ultratech Cement Plant Baga or any other Transport Society situated in the HP for carrying of Cement/Clinker.

The desirous Ex-Servicemen for attachment of their trucks with this Corporation shall submit their application from 01st January, 2022 to 31st January, 2022 on the prescribed Format along with Rs. 500/- (Five hundred only) in shape of Demand Draft in favour of H.P. Ex-Servicemen Corporation as service fee. The applications received after due date shall not be considered. The seniority list will be prepared and it shall be given in order of retirement. If two candidates have retired on the same date then the candidate who have put in longer service in the Army shall rank higher in seniority. The seniority list will be drawn up by this Corporation by 28th Feb, 2022 and will be displayed on Notice Board of the Corporation. All Ex-Servicemen may inspect the same on the Notice Board.

The Ex-Servicemen who are in Govt./Public Sector Undertakings, Banks etc, will not be eligible to submit any application for attachment of truck. If the truck of any Ex-serviceman who is re-employed in Govt./Public Sector Undertakings, Banks etc, is already attached with any of the above Cement Companies he will have to surrender the same. The Ex-Servicemen who have not his/their own truck will be given a time for a period of three months to buy the truck from the date he/she is allotted a slot from the seniority list. In case of the Ex-Servicemen failure to buy the truck within three months then his/her name shall be omitted from the list.
