
The applications are hereby invited on the prescribed Proforma from the desirous Ex-servicemen and their widows, who want to attach the trucks. Only those Ex-servicemen are eligible whose truck have not been attached earlier with ACC (Adani Group) Ltd. Barmana, Ambuja Cement (Adani Group) Ltd., Darlaghat and Ultratech Cement Plant Baga or any other Transport Society situated in the HP for carrying of Cement/ Clinker.

The ex-servicemen who have been retired or are serving in Govt. Service/PSUs, Banks etc, will not be eligible to submit the application for attachment of truck. The ex-servicemen and widows can submit the application who have retired from Army Service within 05 years from the date of discharge. The ex-servicemen can plied the truck upto 60 years or 15 years, whichever is later in future.

The desirous ex-servicemen for attachment of their truck with this Corporation shall submit their application from 01st January, 2023 to 31st January, 2023 on the prescribed Proforma along with Rs. 500/- in shape of Demand Draft in favour of HP Ex-servicemen Corporation as service fee. The applications received after due date shall not be considered.

The seniority list will be drawn up by this Corporation by 28th Feb, 2023 and will be displayed on Notice Board of the Corporation. All ex-servicemen may inspect the same on the Notice Board and Website of this Corporation.

Note: As on date 4,449 ex-servicemen have applied for attachment of truck, out of which 889 trucks have been attached from the seniority list in last eleven years.
