


## NOTICE

The applications are hereby invited on the prescribed proforma from the desirous ex-servicemen and their widows, who want to attach the trucks for carrying of Cement/ Clinker from ACC (Adani Group) Ltd. Barmana, Ambuja Cement (Adani Group) Ltd., Darlaghat and Ultratech Cement Plant Baga. Only those Ex-servicemen/ their widows are eligible whose truck have not been attached earlier with these plants or any other Transport Society situated in the HP.

### Terms & Conditions

1. The ex-servicemen and their widows who are/ were re-employed in Govt. Service/ PSUs/ Banks etc. after retirement from the defence services will not be eligible to submit the application for attachment of truck. Those ex-servicemen and widows can submit the application who have been discharged from Defence Service within 05 years before 31.12.2024. The ex-servicemen can ply the truck upto 60 years or 15 years, whichever is later in future.
2. The ex-servicemen desirous for attachment of their truck with this Corporation shall submit their application from 01<sup>st</sup> January, 2025 to 31<sup>st</sup> January, 2025 on the prescribed proforma along with Rs. 500/- in shape of Demand Draft in favour of HP Ex-servicemen Corporation as service fee. The applications received after due date will not be considered.
3. The seniority list will be drawn up by this Corporation by 28<sup>th</sup> Feb, 2025 and will be displayed on notice board of the Corporation. All ex-servicemen may inspect the same on the notice board and website of this Corporation.
4. As on date 4,613 ex-servicemen have applied for attachment of truck, out of which trucks upto Sr. No. 1413 have been attached from the seniority list in last thirteen years.
